Plaintiffs, the Federal Trade Commission (“FTC” or “Commission”) and the states of Alabama, Alaska, Arizona, Arkansas, California, Colorado, Connecticut, Delaware, Florida, Georgia, Hawaii, Idaho, Illinois, Indiana, Iowa, Kansas, Kentucky, Louisiana, Maine, Maryland, Massachusetts, Michigan, Minnesota, Mississippi, Missouri, Montana, Nebraska, Nevada, New Hampshire, New Jersey, New Mexico, New York, North Carolina, North Dakota, Ohio, Oklahoma, Oregon, Pennsylvania, Rhode Island, South Carolina, South Dakota, Tennessee, Texas, Utah, Vermont, Virginia, Washington, West Virginia, Wisconsin, Wyoming, and the District of Columbia have filed a complaint for a permanent injunction and other equitable relief against Defendants Cancer Fund of America, Inc., also d/b/a Breast Cancer Financial Assistance Fund (“CFA”), Cancer Support Services, Inc. (“CSS”), Children’s Cancer Fund of America, Inc. (“CCFOA”), and The Breast Cancer Society, Inc., also d/b/a The Breast Cancer Society of America

1 (“BCS”), Rose Perkins, and other individuals, alleging that all named Defendants
2 violated, among other statutes, the Federal Trade Commission Act, 15 U.S.C. § 45, the
3 Telemarketing and Consumer Fraud and Abuse Prevention Act (“Telemarketing Act”),
4 15 U.S.C. §§ 6101-6108, and the Unfair and Deceptive Acts and Practices and Charitable
5 Solicitation laws of the Plaintiff States. Plaintiffs and Defendants Children’s Cancer
6 Fund of America, Inc., and Rose Perkins stipulate to the entry of this Stipulated Order for
7 Permanent Injunction and Monetary Judgment Against Children’s Cancer Fund of
8 America, Inc. and Rose Perkins (“Order”). Plaintiffs and Defendant Children’s Cancer
9 Fund of America, Inc. also stipulate to the entry of a separate and concurrently filed
10 Stipulated Order Appointing Receiver Over Children’s Cancer Fund of America, Inc.
11 Together, this Order and the CCFOA Receivership Order resolve all matters in dispute in
12 this action between Plaintiffs and Defendants Children’s Cancer Fund of America, Inc.
13 and Rose Perkins.

14 THEREFORE, IT IS ORDERED as follows:

15 **GRANTING** the parties’ Stipulation Re Order for Permanent Injunction and
16 Monetary Judgment Against Children’s Cancer Fund of America, Inc., and Rose Perkins
17 (Doc. 3);

18 **FINDINGS**

- 19 1. This Court has jurisdiction over this matter.
20 2. Venue is proper in the District of Arizona.
21 3. The Complaint charges that Defendants CCFOA and Perkins, among
22 others, engaged in deceptive acts or practices by making false and misleading claims in
23 charitable solicitations in violation of Section 5 of the FTC Act, 15 U.S.C. § 45, the
24 Telemarketing Sales Rule (“TSR”), 16 C.F.R. Part 310, and the following state statutes
25 regulating charitable solicitations and prohibiting deceptive and/or unfair trade practices:

21 4. Defendants CCFOA and Perkins neither admit nor deny any of the
22 allegations in the Complaint, except as specifically stated in this Order. Only for
23 purposes of this action, Defendants admit the facts necessary to establish jurisdiction.

24 5. Defendants CCFOA and Perkins waive any claim that they may have under
25 the Equal Access to Justice Act, 28 U.S.C. § 2412, concerning the prosecution of this
26 action through the date of this Order, and agree to bear their own costs and attorney fees.

27 6. Defendants CCFOA and Perkins waive all rights to appeal or otherwise
28 challenge or contest the validity of this Order.

7. Entry of this Order is in the public interest.

1 **DEFINITIONS**

2 For purposes of this Order, the following definitions shall apply:

3 1. “Defendants” means the individual defendant Rose Perkins and the
4 corporate defendant Children’s Cancer Fund of America, Inc., individually, collectively,
5 or in any combination.

6 2. “CCFOA” means Children’s Cancer Fund of America, Inc., and its
7 successors and assigns.

8 3. “Perkins” means individual defendant Rose Perkins.

9 4. “CCFOA Receivership Order” means the “Stipulated Order Appointing
10 Receiver Over Children’s Cancer Fund of America, Inc.”

11 5. “CCFOA Receiver” means the receiver appointed by the CCFOA
12 Receivership Order.

13 6. “Person” means a natural person, an organization or other legal entity,
14 including a corporation, partnership, sole proprietorship, limited liability company,
15 association, cooperative, or any other group or combination acting as an entity.

16 7. “Charitable contribution” means any donation or gift of money or any other
17 thing of value.

18 8. “Donor” or “consumer” means any person solicited to make a charitable
19 contribution.

20 9. “Fundraising” means a plan, program, or campaign that is conducted to
21 induce charitable contributions by mail, telephone, electronic mail, social media, or any
22 other means.

23 10. “Nonprofit organization” means any person that is, or is represented to be, a
24 nonprofit entity, or that has, or is represented to have, a charitable purpose, specifically
25 including but not limited to any such entity that purports to benefit, either in whole or in
26 part, individuals who suffer or have suffered from cancer.

27 11. “Plaintiff States” means the states of Alabama, Alaska, Arizona, Arkansas,
28 California, Colorado, Connecticut, Delaware, Florida, Georgia, Hawaii, Idaho, Illinois,

1 Indiana, Iowa, Kansas, Kentucky, Louisiana, Maine, Maryland, Massachusetts,
2 Michigan, Minnesota, Mississippi, Missouri, Montana, Nebraska, Nevada, New
3 Hampshire, New Jersey, New Mexico, New York, North Carolina, North Dakota, Ohio,
4 Oklahoma, Oregon, Pennsylvania, Rhode Island, South Carolina, South Dakota,
5 Tennessee, Texas, Utah, Vermont, Virginia, Washington, West Virginia, Wisconsin,
6 Wyoming, and the District of Columbia.

7 12. "Solicitor" means any person who solicits a charitable contribution.

8 13. "Telemarketing" means a plan, program, or campaign that is conducted to
9 induce the purchase of goods or services or a charitable contribution, by use of one or
10 more telephones and that involves a telephone call, whether or not covered by the
11 Telemarketing Sales Rule.

12 14. "And" and "or" shall be construed both conjunctively and disjunctively to
13 make the applicable sentence or phrase inclusive rather than exclusive.

14 **ORDER**

15
16 **I. CORPORATE DISSOLUTION**

17 IT IS FURTHER ORDERED that, pursuant to the CCFOA Receivership Order of
18 which CCFOA has consented to entry, the CCFOA Receiver shall take the steps
19 necessary to cause CCFOA to be dissolved and to cease to exist as a corporate entity.

20 **II. PROHIBITIONS RELATED TO THE SOLICITATION AND CONTROL**
21 **OF CHARITABLE ASSETS**

22 IT IS FURTHER ORDERED that Perkins is permanently restrained and enjoined
23 from engaging in the following activities individually or in concert with other persons or
24 entities, directly or indirectly:

25 A. Receiving any payment or other financial benefit for: (1) participating or
26 assisting in the solicitation of charitable contributions, directly or indirectly, including by
27 advising, acting as an independent contractor or as a fundraising consultant, supplying
28 contact or donor lists, or providing caging, mail processing, or fulfillment services, or

1 (2) controlling, directly or indirectly, or holding a majority ownership interest in, any
2 entity engaged in the business of fundraising; and

3 B. Establishing, operating, controlling, or managing any nonprofit
4 organization or other entity that holds charitable assets, or any program thereof, directly
5 or indirectly, whether compensated or not, including by serving as a founder,
6 incorporator, officer, director, trustee, chief executive, manager, supervisor, or other
7 fiduciary; and

8 C. Managing, controlling, directing, distributing, or accounting for the use or
9 application of any charitable asset, or participating or assisting in managing, controlling,
10 directing, distributing, or accounting for the use or application of any charitable asset,
11 directly or indirectly, whether compensated or not, including by acting as an independent
12 contractor, advisor, or consultant;

13 D. **Provided that**, subject to the limitations of subsections II.A - C above,
14 Perkins may be employed by or volunteer for any nonprofit organization in any capacity
15 not prohibited by the above, such as working in any non-supervisory role unrelated to the
16 solicitation, management, custody, control, or distribution of any charitable asset.

17 **III. PROHIBITION ON MISREPRESENTATIONS**

18 IT IS FURTHER ORDERED that Perkins, CCFOA, its officers, agents,
19 employees, and independent contractors, and all other persons in active concert or
20 participation with them who receive actual notice of this Order, whether acting directly or
21 indirectly, are hereby permanently restrained and enjoined from making material
22 misrepresentations in connection with the sale of consumer goods or services.

23 **IV. TELEMARKETING SALES RULE COMPLIANCE**

24 IT IS FURTHER ORDERED that Perkins, CCFOA, its officers, agents,
25 employees, and independent contractors, and all other persons in active concert or
26 participation with them who receive actual notice of this Order, whether acting directly or
27 indirectly, are hereby permanently restrained and enjoined from violating, or assisting
28

1 others in violating, any provision of the TSR, 16 C.F.R. Part 310, as currently
 2 promulgated or as it hereafter may be amended.

3 **V. COMPLIANCE WITH STATE LAW**

4 IT IS FURTHER ORDERED that CCFOA, its officers, agents, employees, and
 5 independent contractors, and Perkins, whether acting directly or indirectly, are hereby
 6 permanently restrained and enjoined from violating, or assisting others in violating, any
 7 provision of the following state laws:

1 **VI. COOPERATION**

2 IT IS FURTHER ORDERED that CCFOA and Perkins must cooperate fully with
3 Plaintiffs' representatives in this case and in any investigation related to or associated
4 with the transactions or the occurrences that are the subject of the Complaint. CCFOA
5 and Perkins must provide truthful and complete information, evidence, and testimony.
6 Perkins must appear, and CCFOA must cause its officers, employees, representatives, or
7 agents to appear for interviews, discovery, hearings, trials, and any other proceedings that
8 any Plaintiff's representative may reasonably request upon five days written notice, or
9 other reasonable notice, at such places and times as any Plaintiff's representative may
10 designate, without the service of a subpoena.

11 **VII. MONETARY JUDGMENT**

12 IT IS FURTHER ORDERED that judgment is hereby entered against Defendants
13 as follows:

14 A. Judgment in the amount of thirty million, seventy-nine thousand, eight
15 hundred twenty-one dollars (\$30,079,821) is entered in favor of Plaintiffs against
16 CCFOA and Perkins, jointly and severally, as equitable monetary relief;

17 B. Payments by CCFOA:

18 1. In partial satisfaction of this judgment, the CCFOA Receiver shall
19 take the necessary steps to wind down the affairs of CCFOA and liquidate its assets in the
20 manner set forth in the CCFOA Receivership Order, and deposit all net assets to the short
21 term court ordered trust fund (hereinafter "STCO Fund") described in Section VIII.E,
22 below;

23 2. Payments made by the CCFOA Receiver to the STCO Fund on
24 behalf of CCFOA shall be credited toward satisfaction of the judgment against CCFOA;

25 C. Payments by Perkins:

26 1. The judgment shall be suspended as to Perkins, subject to
27 Subsections VII.C.2 - 3, below. Plaintiffs' agreement to the suspension of the judgment
28 owed by Perkins is expressly premised upon the truthfulness, accuracy, and completeness

1 of Perkins' sworn financial statements and related documents submitted to Plaintiffs,
2 namely, the Financial Statement of Individual, signed on March 16, 2015, including
3 attachments;

4 2. The suspension of the judgment will be lifted as to Perkins if, upon
5 motion by any Plaintiff, the Court finds that Perkins failed to disclose any material asset,
6 materially misstated the value of any asset, or made any other material misstatement or
7 omission in the representations made in her Financial Statement, identified above. If the
8 suspension of the judgment is lifted pursuant to this provision, the judgment becomes
9 immediately due in the amount specified in Subsection VII.A above as to Perkins (which
10 the Parties stipulate for purposes only of this Section represents the consumer injury
11 alleged in the Complaint for which Perkins is jointly and severally liable with CCFOA),
12 less any payment previously made pursuant to this Section, plus interest computed from
13 the date of entry of this Order.

14 3. The suspension of the judgment will be lifted as to Perkins if, upon
15 motion by any Plaintiff State, the Court finds that Perkins has violated any provision of
16 Section II, above, and a judgment in the amount set forth in Subsection VII.A above, less
17 any prior payments by Perkins or CCFOA, becomes immediately due as to Perkins. The
18 judgment amount shall be payable to the moving Plaintiff State, which shall use any
19 money collected pursuant to the requirements of Section VIII.E.2, below.

20 **VIII. ADDITIONAL MONETARY PROVISIONS**

21 IT IS FURTHER ORDERED that:

22 A. CCFOA and Perkins relinquish dominion and all legal and equitable right,
23 title, and interest in all assets transferred pursuant to this Order and the CCFOA
24 Receivership Order, and may not seek the return of any assets;

25 B. The facts alleged in the Complaint will be taken as true, without further
26 proof, in any subsequent civil litigation by or on behalf of the Plaintiffs or the CCFOA
27 Receiver, including in a proceeding to enforce their rights to any payment or monetary
28

1 judgment pursuant to this Order, such as a nondischargeability complaint in any
2 bankruptcy case;

3 C. The facts alleged in the Complaint establish all elements necessary to
4 sustain an action by Plaintiffs pursuant to Section 523(a)(2)(A) of the Bankruptcy Code,
5 11 U.S.C. § 523(a)(2)(A), and this Order will have collateral estoppel effect for such
6 purposes;

7 D. CCFOA and Perkins acknowledge that their Taxpayer Identification
8 Numbers, Social Security Numbers and/or Employer Identification Numbers, which
9 Defendants previously submitted to Plaintiffs, may be used for collecting and reporting
10 on any delinquent amount arising out of this Order, in accordance with 31 U.S.C. § 7701;

11 E. Payment to the Plaintiff States:

12 1. All money paid to the Plaintiff States pursuant to this Order shall be
13 made by wire transfer to the Litigation Deposits Trust Fund (Fund Code “T-xx-909N”),
14 an interest bearing trust fund held by the Hawaii Attorney General’s Office in trust for
15 the Plaintiff States (“the short-term court ordered trust fund” or “STCO Fund”);

16 2. The STCO Fund shall be used to pay: (a) pursuant to cy pres,
17 qualifying charitable organizations with charitable purposes substantially similar to the
18 purposes for which CCFOA solicited funds, and (b) the Plaintiff States to reimburse costs
19 of the investigation and to pay attorneys’ fees. When payment(s) from the STCO Fund
20 are appropriate, the Plaintiff States shall submit to this Court a Motion and Proposed
21 Order recommending cy pres recipients and the amounts to be paid to such recipients
22 and/or the amounts to be paid to reimburse the Plaintiff States for their costs and
23 attorneys’ fees. The Hawaii Attorney General shall distribute monies from the STCO
24 Fund only as authorized and directed by this Court. CCFOA and Perkins have no right to
25 challenge any recommendations regarding monetary distributions made by the Plaintiff
26 States.

1 **IX. ORDER ACKNOWLEDGMENTS**

2 IT IS FURTHER ORDERED that Perkins provide acknowledgment of receipt of
3 this Order:

4 A. Perkins, within seven days of entry of this Order, must submit to Plaintiff
5 Federal Trade Commission an acknowledgment of receipt of this Order sworn under
6 penalty of perjury;

7 B. For five years after entry of this Order, Perkins, for any business that she,
8 individually or collectively with any other Defendant named in this matter, is the majority
9 owner or controls directly or indirectly, must deliver a copy of this Order to: (1) all
10 principals, officers, directors, and LLC managers and members; (2) all employees,
11 agents, and representatives who participate in conduct related to the subject matter of this
12 Order; and (3) any business entity resulting from any change in structure as set forth in
13 Section X below. Delivery must occur within seven days of entry of this Order for
14 current personnel. For all others, delivery must occur before they assume their
15 responsibilities; and

16 C. From each individual or entity to which Perkins delivered a copy of this
17 Order, Perkins must obtain, within 30 days, a signed and dated acknowledgment of
18 receipt of this Order.

19 **X. COMPLIANCE REPORTING**

20 IT IS FURTHER ORDERED that Perkins make timely submissions to Plaintiff
21 Federal Trade Commission.

22 A. One year after entry of this Order, Perkins must submit a compliance
23 report, sworn under penalty of perjury. Perkins must:

24 1. identify all her telephone numbers and all physical, postal, email and
25 Internet addresses, including all residences;

26 2. identify all her business activities, including any business for which
27 she performs services whether as an employee or otherwise and any entity in which she
28 has any ownership interest;

1 3. describe in detail her involvement in each such business, including
2 title, role, responsibilities, participation, authority, control, and any ownership;

3 4. identify all such businesses by all of their names, telephone
4 numbers, and physical, postal, email, and Internet addresses;

5 5. describe the activities of each business, including the goods and
6 services offered, the means of advertising, marketing, sales, methods of payment, and the
7 involvement of any other Defendant named in this matter (which Perkins must describe if
8 she knows or should know due to her own involvement);

9 6. identify the primary physical, postal, and email address and
10 telephone number, as designated points of contact, which Plaintiffs or their
11 representatives may use to communicate with her;

12 7. for all her activities with any nonprofit organization that Perkins
13 undertakes in connection with Section II.D of this Order:

14 a. identify all such nonprofit organizations by all of their names,
15 telephone number[s], and physical, postal, email, and Internet addresses; and

16 b. describe in detail her involvement in each such nonprofit
17 organization, including any title, role, responsibilities, participation, authority, and
18 control;

19 8. describe in detail whether and how Perkins is in compliance with
20 each Section of this Order; and

21 9. provide a copy of each Order Acknowledgment obtained pursuant
22 to this Order, unless previously submitted to Plaintiff Federal Trade Commission.

23 B. For ten years after entry of this Order, Perkins must submit a compliance
24 notice, sworn under penalty of perjury, within 14 days of any change in the following:

25 1. Perkins must report any change in: (a) any designated point of
26 contact; or (b) the structure of any entity that she has any ownership interest in or controls
27 directly or indirectly that may affect compliance obligations arising under this Order,
28 including: creation, merger, sale, or dissolution of the entity or any subsidiary, parent, or
affiliate that engages in any acts or practices subject to this Order.

1 2. Perkins must report any change in: (a) name, including aliases or
2 fictitious names, or residence address; or (b) title or role in any business activity,
3 including any business for which she performs services, whether as an employee or
4 otherwise, and any entity in which she has any ownership interest or controls, directly or
5 indirectly, and identify the name, physical address, and any Internet address of the
6 business or entity.

7 3. If Perkins is employed by any nonprofit organization in any capacity
8 permitted by Section II.D of this Order or otherwise, she must report any change in title
9 or role with that nonprofit organization.

10 C. Perkins must submit notice of the filing of any bankruptcy petition,
11 insolvency proceeding, or similar proceeding by or against her within 14 days of its
12 filing.

13 D. Any submission required by this Order to be sworn under penalty of perjury
14 must be true and accurate and comply with 28 U.S.C. § 1746, such as by concluding: “I
15 declare under penalty of perjury under the laws of the United States of America that the
16 foregoing is true and correct. Executed on [date] at [location]” and supplying the date,
17 location, signatory’s full name, title (if applicable), and signature.

18 E. Unless otherwise directed by a Commission representative in writing, all
19 submissions to Plaintiff Federal Trade Commission pursuant to this Order must be
20 emailed to DEbrief@ftc.gov or sent by overnight courier (not the U.S. Postal Service) to:

26 **XI. RECORDKEEPING**

27 IT IS FURTHER ORDERED that Perkins must create certain records for ten years
28 after entry of this Order, and retain each such record for five years. Specifically, for any

1 business that she, individually or collectively with any other Defendant named in this
2 matter, is a majority owner or controls directly or indirectly, she must create and retain
3 the following records:

4 A. Accounting records showing revenues from all goods or services sold or
5 billed;

6 B. Personnel records showing, for each person providing services, whether as
7 an employee or otherwise, that person's name; address; telephone number; job title or
8 position; dates of service; and reason for termination (if applicable);

9 C. Records of all consumer complaints, whether received directly or indirectly,
10 such as through a third party, and any response;

11 D. All records necessary to demonstrate full compliance with each provision
12 of this Order, including all submissions to Plaintiff Federal Trade Commission; and

13 E. A copy of each unique advertisement or other marketing material.

14 **XII. COMPLIANCE MONITORING**

15 IT IS FURTHER ORDERED that, for purposes of monitoring Perkins'
16 compliance with this Order, including the accuracy of the financial representations upon
17 which the judgment was suspended:

18 A. Within 14 days of receipt of a written request from a representative of any
19 Plaintiff, Perkins must submit additional compliance reports or other requested
20 information, which must be sworn under penalty of perjury; appear for depositions; and
21 produce documents for inspection and copying. Plaintiffs are also authorized to obtain
22 discovery, without further leave of court, using any of the procedures prescribed by
23 Federal Rules of Civil Procedure 29, 30 (including telephonic depositions), 31, 33, 34,
24 36, 45, and 69.

25 B. For matters concerning this Order, Plaintiffs are authorized to communicate
26 directly with Perkins. Perkins must permit representatives of any Plaintiff to interview
27 any employee or other person affiliated with her who has agreed to such an interview.
28 The person interviewed may have counsel present.

1 C. Plaintiffs may use all other lawful means, including posing, through their
2 representatives, as consumers, suppliers, or other individuals or entities, to Perkins or any
3 individual or entity affiliated with her, without the necessity of identification or prior
4 notice. Nothing in this Order limits Plaintiff Federal Trade Commission's lawful use of
5 compulsory process, pursuant to Sections 9 and 20 of the FTC Act, 15 U.S.C. §§ 49, 57b-
6 1, or the Plaintiff States' lawful use of relevant state laws governing pre-suit investigation
7 and discovery.

8 D. Upon written request from a representative of the Commission or any
9 Plaintiff state, any consumer reporting agency must furnish a consumer report concerning
10 Perkins pursuant to Section 604(1) of the Fair Credit Reporting Act, 15 U.S.C.
11 §1681b(a)(1).


12 **XIII. RETENTION OF JURISDICTION**

13 IT IS FURTHER ORDERED that that this Court retains jurisdiction of this matter
14 for purposes of construction, modification, and enforcement of this Order.

15 **XIV. STATE COURT ENFORCEMENT**

16 Without limiting the above provisions, CCFOA and Perkins agree that the
17 provisions of Sections II, III, and V of this Order may be enforced by any Plaintiff State
18 in a court of general jurisdiction in that Plaintiff's state if that Plaintiff state has reason to
19 believe that persons in its state have been affected, and Defendants CCFOA and Perkins
20 consent to any such court's jurisdiction for purposes of enforcing the terms of Sections II,
21 III, and V of this Order.
