
IT IS HEREBY ORDERED, ADJUDGED, AND DECREED THAT:

1. The Commonwealth's Motion for Entry of an Order Pursuant to Virginia Code § 59.1-205 is GRANTED.

2. Pursuant to Virginia Code § 59.1-205, the Commonwealth of Virginia, as trustee, shall have additional judgment against and recover from KLMN Readers Services, Inc. the sum of \$4,391.00, with interest from this date at the judgment rate of six percent (6%) per annum, for the use and benefit of, and for restitution to, the individuals listed in Exhibit 1, who paid monies to the Defendant for goods and services which were not provided, and whose loss was proven at a hearing on the Motion. This Judgment shall be in addition to the relief awarded in the

Permanent Injunction and Final Judgment entered in this matter on September 24, 2014.


